## **Australia – Modular Artillery Charge Systems, XM982 Block Ia-1 Excalibur Projectiles**

WASHINGTON, April 21, 2008 – The Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to Australia of Modular Artillery Charge Systems and XM982 Block Ia-1 Excalibur Projectiles as well as associated equipment and services. The total value, if all options are exercised, could be as high as \$58 million.

The Government of Australia requested a possible sale of 2,400 Modular Artillery Charge Systems (MACS), 250 XM982 Block Ia-1 Excalibur Unitary Projectiles with base bleed units, 43 Portable Excalibur Fire Control Systems (PEFCS), 43 AN/PRC-119 Single Channel Ground and Airborne Radio System (SINCGARS) w/o GPS, training ammunition, containers, support equipment, spare and repair parts, publications and technical data, maintenance, personnel training and training equipment, U.S. Government and contractor representatives' engineering and technical support services, and other related elements of logistics support. The estimated cost is \$58 million.

Australia is one of our most important allies in the Western Pacific. The strategic location of this political and economic power contributes significantly to ensuring peace and economic stability in the region. Australia's efforts in peacekeeping and humanitarian operations in Iraq and in Afghanistan have had a significant impact on regional, political, and economic stability and have served U.S. national security interests. This proposed sale is consistent with those objectives and facilitates burden sharing with our allies.

The proposed sale will enhance Australia's defensive capabilities and increase interoperability with United States and multi-national forces supporting coalition operations. The country will have no difficulty absorbing this new capability into its military.

The proposed sale of this equipment and support will not affect the basic military balance in the region.

## **Canada - CH-47D CHINOOK Helicopters**

WASHINGTON, April 21, 2008 – The Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to Canada of CH-47D CHINOOK Helicopters as well as associated equipment and services. The total value, if all options are exercised, could be as high as \$375 million.

The Government of Canada has requested a possible sale of six CH-47D CHINOOK Helicopters with 12 (2 per helicopter) T55-GA-714A Turbine engines, 4 M240H Machine Guns, 30 AN/AVS-6/7(V)1 Aviation Night Vision Imaging Systems, and 2 spare T-55-GA-714A Turbine engines, mission equipment, communication and navigation equipment, ground support equipment, spare and repair parts, special tools and test equipment, publications and technical data, site survey, Quality Assurance Team support, contractor technical and logistics personnel services, and other related elements of logistics support. The estimated cost is \$375 million.

This proposed sale will contribute to the foreign policy and national security objectives of the United States by improving the military capabilities of Canada and furthering weapon system standardization and interoperability with U.S. forces. Canadian deployments in support of peacekeeping and humanitarian operations have made a significant impact to global political and economic stability and have served U.S. national security interests.

Canada needs these helicopters to enhance its capabilities in the Global War on Terrorism (GWOT). Having the same configuration as the U.S. would greatly contribute to Canada's military capability by making it a more sustainable coalition force to support GWOT. The proposed sale of this equipment and support will not affect the basic military balance in the region.

The prime contractors will be: The Boeing Company in Ridley Park, PA; Honeywell, Inc. in Phoenix, AZ; and FN Enterprise in Lubbock, TX. There are no known offset agreements proposed in connection with this potential sale.

Implementation of this proposed sale will require the assignment of contractor representatives to Canada and in the theater of operations for an unspecified amount of time. Also, approximately 6 U.S. Government personnel will participate in program management and technical reviews in-country for one to two-week intervals twice annually to support site surveys and delivery of the CH-47D helicopters in-country.

There will be no adverse impact on U.S. defense readiness as a result of this proposed sale.

## **Australia - AEGIS Combat System Components for Air Warfare Destroyer Program**

WASHINGTON, May 5, 2008 – The Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to Australia of AEGIS Combat System components as well as associated equipment and services. The total value, if all options are exercised, could be as high as \$450 million.

The Government of Australia requested a possible sale of the AEGIS Combat System and select combat system and communication components consisting of 3 AN/SPQ-9B Horizon Search Radars, 3 Cooperative Engagement Capability Systems, 3 Naval Fire Control Systems, 3 Multi-Functional Information Distribution Systems, AN/SLQ-25A Nixie Countermeasure Suite, MK160 Gun Computer System, AIMS MK XII Identification Friend or Foe (IFF) for the Air Warfare Destroyer platform, communication and information distribution systems, U.S. Government and contractor engineering and logistics personnel services, personnel training and training equipment, support and test equipment, spare and repair parts, publications and technical documentation, and other related elements of logistics support. The estimated cost is \$450 million.

Australia is one of our most important allies in the Western Pacific. The strategic location of this political and economic power contributes significantly to ensuring peace and economic stability in the region. Australia's efforts in peacekeeping and humanitarian operations in Iraq and in Afghanistan have had a significant impact on regional political and economic stability and have served U.S. national security interests. This proposed sale is consistent with those objectives and facilitates burden sharing with our allies.

The proposed sale of the AEGIS Combat System and components to Australia will contribute to U.S. security objectives by providing a coalition partner with significantly improved Air Warfare capability. This will improve the Royal Australian Navy's ability to participate in coalition operations, will enhance the lethality of its Air Warfare Destroyer platform, and will provide common logistical support with the U.S. Navy. The Royal Australian Navy can easily integrate the capabilities of the AEGIS Weapons Systems into its concept of operations. Australia will have no difficulty absorbing these systems into its armed forces.

The proposed sale of this equipment and support will not affect the basic military balance in the region.

## **Australia - Large Aircraft Infrared Countermeasures (LAIRCM) Systems**

WASHINGTON, May 21, 2008 – The Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to Australia of Large Aircraft Infrared Countermeasures (LAIRCM) Systems as well as associated equipment and services. The total value, if all options are exercised, could be as high as \$100 million.

The Government of Australia has requested a possible sale of AN/AAQ-24(V) LAIRCM systems to be installed on C-130J aircraft, including the following Line Replaceable Units (LRUs): 12 Control Interface Units (CIU), 12 System Processors (SP), 12 AN/AAR-54(V) Missile Warning Systems (MWS), 12 Small Laser Transmitter Assemblies (SLTA), Operational Flight Program (OFP) software, and spare LRUs (6 CIUs, 6 SPs, 7 individual MWS sensors, and 12 SLTAs). Also included: installation support, engineering change proposals, minor modifications, support equipment, spare and repair parts, publications and technical documents, repair and return, depot maintenance, training and training equipment, U.S. Government and contractor technical assistance, and other related elements of logistics and program support. The estimated cost is \$100 million.

Australia is an important ally in the Western Pacific. The strategic location of this political and economic power contributes significantly to ensuring peace and economic stability in the region. Australia's efforts in peacekeeping and humanitarian operations have made a significant impact to regional political and economic stability and have served U.S. national security interests. This proposed sale is consistent with those objectives and facilitates burden sharing with our allies.

These systems will be integrated on Australia's C-130J aircraft. The proposed sale of this equipment and support will not alter the basic military balance in the region.

The principal contractor will be Northrop Grumman Corporation, Rolling Meadows, IL. There are no known offset agreements proposed in connection with this potential sale.

Implementation of this sale will require approximately five contractor representatives to provide training, installation, and maintenance support technical and logistics support in Australia for twelve weeks after delivery. U.S. Government and contractor representatives will also participate in program management and technical reviews for two-week intervals annually.

## **Canada - M777 155mm Light-Weight Towed Howitzers**

WASHINGTON, June 17, 2008 – The Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to Canada of M777 155mm Light-Weight Towed Howitzers as well as associated equipment and services. The total value, if all options are exercised, could be as high as \$114 million.

The Government of Canada has requested a possible sale of 37 M777 155mm Light-Weight Towed Howitzers, spare and repair parts, support and test equipment, publications and technical documentation, maintenance, personnel training and training equipment, U.S. Government and contractor representatives' technical assistance, engineering and logistics support services, and other related elements of logistics support. The estimated cost is \$114 million.

This proposed sale will contribute to the foreign policy and national security objectives of the United States by improving the military capabilities of Canada and the Canadian military's interoperability with U.S. forces. Canadian deployments in support of peacekeeping and humanitarian operations have enhanced global political and economic stability and have served U.S. national security interests.

This proposed sale would greatly contribute to Canada's military capability by making it a more sustainable coalition force to support the Global War on Terror. Canada currently operates the M777 lightweight howitzers and will use these new howitzers to protect its deployed troops, and give them the ability to operate in hazardous conditions. Canada will have no difficulty absorbing the howitzers into its armed forces.

The proposed sale of this equipment and support will not affect the basic military balance in the region.

The prime contractors will be BAE Land Systems in Hattiesburg, Mississippi, and Howmet Castings, Alcoa Business in Whitehall, Michigan. There are no known offset agreements proposed in connection with this potential sale.

The proposed sale requires engineering technical support for approximately two U.S. government representatives and five contractor representatives for one year.

## **Australia – AEGIS Combat System Components for Air Warfare Destroyer Program**

WASHINGTON, July 11, 2008 – On July 9, the Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to the Government of Australia of the AEGIS Combat System and associated equipment and services. The total value, if all options are exercised, could be as high as \$700 million.

The Government of Australia has requested a possible sale of the AEGIS Combat System and select combat system and communication components consisting of 1 MK 41 Vertical Launch System, 1 AN/SPQ-9B Horizon Search Radar, 1 Cooperative Engagement Capability System, 1 Naval Fire Control System, 1 Multi-Functional Information Distribution System, AN/SLQ-25A Nixie Countermeasure Suite, MK160 Gun Computer System with MK 20 Electro-Optical Sight, AIMS MK XII Identification Friend or Foe (IFF) for the Air Warfare Destroyer platform, communication and information distribution systems, U.S. Government and contractor engineering and logistics personnel services, personnel training and training equipment, support and test equipment, spare and repair parts, publications and technical documentation, and other related elements of logistics support. The estimated cost is \$700 million.

## **Finland – AIM-120C-7 AMRAAM Missiles**

WASHINGTON, July 11, 2008 – On July 9, the Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to Finland of 300 AIM-120C-7 Advanced Medium Range Air-to-Air Missiles (AMRAAM), and associated equipment and services. The total value, if all options are exercised, could be as high as \$435 million.

The Government of Finland has requested a possible sale of 300 AIM-120C-7 AMRAAM, missile containers, spare and repair parts, support and test equipment, publications and technical documentation, personnel training and training equipment, U.S. Government and contractor engineering, technical and logistics support services, and other related elements of logistical and program support. The estimated cost is \$435 million.

This proposed sale will contribute to the foreign policy and national security of the United States by helping to improve the security of a friendly country that has been and continues to be an important force for political stability and economic progress in Europe.

Finland intends to use the AMRAAM missiles on its existing fleet of F/A-18C/D aircraft. The sale of AMRAAM missiles gives Finland credible territorial defense capability by increasing its sustainment capability during defensive operations, and extending the overall lifespan of its missile inventory. Finland, which already has AMRAAM missiles in its inventory, will have no difficulty absorbing these items.

The prime contractor will be Raytheon Electronic and Missile Systems of Tucson, Arizona. Offset agreements associated with this proposed sale are expected, but at this time the specific offset agreements are undetermined and will be defined in negotiations between the purchaser and contractor.

Implementation of this sale will not require the assignment of any additional U. S. Government personnel in-country.

## **Germany - Tornado Aircraft Training and Logistics Support**

WASHINGTON, July 11, 2008 – On July 9, the Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to the Federal Republic of Germany the continuation of base services as well as associated support. The total value, if all options are exercised, could be as high as \$250 million.

The Government of Germany has requested a possible sale for the continuation of base services for the German Air Force Tornado aircraft operations at Holloman Air Force Base (AFB), New Mexico. Base services provided would be for operations and logistics support including training, fuel, munitions, base operating support, and other related operational/logistics requirements. The estimated cost is \$250 million.

This proposed sale would contribute to the foreign policy and national security objectives of the United States by improving the military capabilities of Germany and enhancing standardization and interoperability with U.S. forces.

Holloman AFB is the only location where the German Air Force trains aircrews in Tornado aircraft operations and tactics. These operations began at U.S. Air Force facilities in 1989.

The proposed sale of this equipment and support will not affect the basic military balance in the region.

There is no prime contractor involved in this program. There are no known offset agreements proposed in connection with this potential sale.

Implementation of this proposed sale will not require the assignment of any U.S. Government or contractor representatives to Germany.

The total value, if all options are exercised, could be as high as \$248 million.

The Government of Australia has requested a possible sale of 57 M777A2 155MM Light-Weight Howitzers, 57 AN/VRC-91F Single Channel Ground and Airborne Radio Systems (SINCGARS), integration, spare and repair parts, support and test equipment, publications and technical documentation, maintenance, personnel training and training equipment, U.S. Government and contractor engineering and logistics support services, and other related elements of logistics support. The estimated cost is \$248 million.

The strategic location of this political and economic power contributes significantly to ensuring peace and economic stability in the region. ## **Iraq - Light Armored Vehicles**

WASHINGTON, July 30, 2008 – The Defense Security Cooperation Agency notified Congress of a possible Foreign Military Sale to Iraq of Light Armored Vehicles as well as associated equipment and services. The total value, if all options are exercised, could be as high as \$3 billion.

The Government of Iraq has requested a possible sale of 392 Light Armored Vehicles (LAVs) which include 352 LAV-25, 24 LAV-CC, and 16 LAV-A (Ambulances); 368 AN/VRC-90E Single Channel Ground and Airborne Radio Systems (SINCGARS); 24 AN/VRC-92E SINCGARS; and 26 M72 Light Anti-Tank Weapons. The following are considered replacements to vehicles/weapons requested in the Military Table of Equipment (MTOE): 5 LAV-R (Recovery), 4 LAV-L (Logistics), 2 Mine Resistant Ambush Protected (MRAP) Vehicles, 41 Medium Tactical Vehicle Replacement (MTVR), 2 MK19 40mm Grenade Machine Guns, 773 9mm Pistols, 93 M240G Machine Guns, and 10 AR-12 rifles. Non-MDE includes ammunition, construction, site survey, spare and repair parts, support equipment, publications and technical data, personnel training and training equipment, contractor engineering and technical support services and other related elements of logistics support. The estimated cost is \$3 billion.

This proposed sale will contribute to the foreign policy and national security of the United States by helping to improve the security of a friendly country. This proposed sale directly supports the Iraqi government and serves the interests of the Iraqi people and the U.S.

The proposed sale of Light Armored Vehicles will enhance the ability of the Iraqi forces to sustain themselves in their efforts to bring stability to Iraq and to prevent overflow of unrest into neighboring countries.

## **Germany - (5) MQ-9 Unmanned Aerial Vehicle Aircraft**
